The Law Enforcement Action Partnership's mission is to unite and mobilize the voice of law enforcement in support of drug policy and criminal justice reforms that will make communities safer by focusing law enforcement resources on the greatest threats to public safety, promoting alternatives to arrest and incarceration, addressing the root causes of crime, and working toward healing police-community relations.

Educational presentations and debates were arranged by LEAP's speakers' bureau and media departments on the war on drugs in general and, in states with initiatives on the ballot, on the benefits of marijuana legalization. LEAP Speakers presented to over 300 audiences including universities, civic clubs, political clubs, and churches. The media department coordinated over 60 op-eds, 15 letters to the editor, 20 press conferences, and 320 interviews for TV programs, radio shows and printed media sources. The media department also created and distributed informational materials to the press.

LEAP speakers attended and presented at over 20 conferences in the U.S. and abroad, including the 2016 California Democratic Party Convention, UNGASS NYC, the Theology and Peace annual conference, the 2016 National Libertarian Convention, and the Young Americans for Liberty convention.

LEAP has a large, active Facebook, LinkedIn, Twitter and YouTube following. During 2016 we redesigned the website, web communications and brand refocusing to further our reach into criminal justice policy reform. We continue outreach to possible allies such as medical associations, civil rights organization, police associations, prison rights groups, etc. We also distribute brochures, DVD's, educational booklets, and t-shirts.
