The Law Enforcement Action Partnership's mission is to unite and mobilize the voice of law enforcement in support of drug policy and criminal justice reforms that will make communities safer by focusing law enforcement resources on the greatest threats to public safety, promoting alternatives to arrest and incarceration, addressing the root causes of crime, and working toward healing police-community relations.

Expanding speakers' bureau: The Programs Department activities in 2017 included recruiting new law enforcement speakers for the organization, speaking to ally organizations about opportunities to get our speakers in front of new audiences, and training speakers to most effectively convince those audiences. We recruited 41 new speakers in 2017, from former U.S. Attorneys to current police chiefs. We engaged with around 41 new ally organizations, discussing opportunities to support their efforts to reform issues from the financial bail system to prisoner reentry. Finally, we developed training and webinars to help our speakers more effectively reach new audiences.

4b (Code:) (Expenses \$ 86,635 including grants of \$ 0) (Revenue \$ 0)

Implementing LEAP mandate: Throughout 2017, the LEAP Development & Communications Department was focused on building relationships with foundations and donors who would be a good fit for our expanded messaging, as well as maintaining relationships with longstanding donors who are primarily interested in drug policy work (special updates, personal contact, etc.). We brought several new major funders on board, and were able to engage a number of longtime donors and inspire them to increase their giving levels. Our grant-writing process highlighted our expanded focus and the opportunities that broader scope presented in terms of both speaker recruitment and building relationships with valuable allies. In mid-January, our new website launched, and throughout the year, we continued to develop and update web content to fit our new messaging, as well as make our site more informative and easier to navigate for visitors. The new site features new content on a more regular basis than our old site, with the addition of a homepage slider offering current news content. Our email list remained active, with more than 50 messages going out to our supporters, including donation appeals and giving campaigns, action alerts, targeted messages by state, and messages encouraging supporters to contact their representatives (this lobbying activity comprised less than 15% of our (Continued on Schedule O, Statement 1)

Media: In 2017, work in the media department resulted in 28 op-eds, 10 letters to the editor, and 230 media interviews and press conferences. The media and recruiting departments coordinated to create an entirely new media communication strategy and training program for incoming speakers. The program emphasizes preparation of talking points, strategic language, speaking to an audience's values, and advanced interview techniques. The program trained more than 40 new speakers last year. In the speaker's bureau, our experts spoke to audiences at more than 70 in-person speaking engagements and met with legislators to discuss general policy issues or specific legislation more than 110 times. Within the speaker's bureau, we began a new project called the PTSD in Law Enforcement Focus Group. Seventeen speakers with personal experiences dealing with PTSD meet every 4-6 weeks on a conference call to discuss the unique challenges of law enforcement and how those impact officer mental health and physical wellness. The goal of the focus group is to create a set of policy recommendations to be distributed to police departments and local and state legislators sometime in 2018.
