Braden Boucek started his career as an Assistant Attorney General working in the Criminal Justice Division of the Tennessee Attorney General's Office. His responsibilities included representing the state before the Court of Criminal Appeals, Tennessee Supreme Court, all Federal District Courts in Tennessee, and the Sixth Circuit Court of Appeals.

In 2005, Boucek became the Assistant U.S. Attorney for the Western District of Tennessee. He served on the Organized Crime and Drug Task Force where he pursued organized crime investigations into national and international drug trafficking organizations including Mexican drug cartels and criminal street gangs. He participated in over a dozen jury trials including complex money laundering and wiretap cases.

In 2011, Boucek transitioned to the Middle District of Tennessee in Nashville. He managed a wide variety of multistate criminal investigations, including: fraud, racketeering, money laundering, and drug conspiracies. He established strong collaborative relationships with federal, regional, and local law enforcement agencies including the F.B.I., Secret Service, Homeland Security, Bureau of Alcohol, Tobacco, Firearms and Explosives (A.T.F.), United States Marshals, Drug Enforcement Agency (D.E.A.), and the Metropolitan Nashville Police Department.

Boucek left the U.S. Attorney's office in 2015 and has since served as the Director of Litigation at the Beacon Center of Tennessee. He has received numerous awards and commendations, including the Organized Crime and Drug Enforcement Task Force (O.C.D.E.T.F.) District Case of the year in 2007 and 2010, Special Achievement Award in 2008, and Distinguished Service Award in 2007. He holds a B.A. in American Studies from the University of Richmond and a J.D. from Florida State University. He resides in the Nashville, Tennessee area.
