- Strong critical thinking and problem-solving skills;
- Good grasp of strategic messaging.

- Personal or professional knowledge of criminal justice, drug policy, and policing issues;
- Experience working in the media or media relations and/or with media outreach;
- Experience improving social media traffic; growing audiences on Facebook, Twitter, Instagram;
- Experience with visual content creation (social media posts, etc);
- Bachelor's degree or higher in communications, marketing, journalism, media production, criminal justice, public policy, or other social sciences.

Write as if you were <u>one of our speakers</u> trying to convince people who are unsure about the bill but who listen to law enforcement. Please sign the op-ed as that speaker, and feel free to use some creative license – within reason – about their experience. Word count: 500-750 words.
