Darren Ullmann is an Undersheriff with the Cowlitz County Sheriff's Office in Washington. He's been with the Sheriff's Office since 2001 and has worked patrol, narcotics, training, search and rescue, civil, and court security. His narcotics work focused on methamphetamine enforcement and required the extensive use of confidential informants.

Undersheriff Ullmann serves on behalf of the Sheriff and acts as second in command. He oversees personnel management, the Budget/Finance Department, the Records Department, and the Department of Emergency Management. Undersheriff Ullmann is also the Commander of the Cowlitz/Wahkiakum Narcotics Task Force and is responsible for leading the multi-agency unit that spans two counties. He also currently sits on the Board of Directors at Columbia Wellness, Cowlitz County's emergency mental health provider. In the midst of the pandemic, Ullmann served as the Planning Section Chief of the COVID-19 Cowlitz County Incident Management Team.

Darren Ullmann is a Washington State certified law enforcement instructor and has developed training for firearms, search and rescue, law enforcement history, and other subjects. He supervised the Deputy Reserve Program and is a past-president of the Washington State Search and Rescue Coordinators Association (WSSARCA), a former President of the Cowlitz County Search and Rescue (SAR) Council, and a former First Vice-President of the Cowlitz County Sergeants and Deputies Guild. Undersheriff Ullmann was the Verification Coordinator for the Registered Sex Offender Address and Residency of Cowlitz County and chaired the Sex Offender Advisory Council (SOAC). Undersheriff Ullmann sat on the End of Sentence Review Committee (ESRC)
