Lt. Colonel Anita Fraser began her law enforcement career in 1989 as a corrections sergeant for the city of Atlanta, Georgia. In 2004, she joined the DeKalb County Police Department as a patrol and field training officer. In 2008, she became a detective crime analyst with the North Central Precinct of the Uniform Division. Her responsibilities included investigating crimes and relaying information to the public regarding crime trends. In 2013, she became an in-service sergeant with the Training Academy where she managed the maintenance and coordination of in-service, intermediate, advanced, and specialized training. In 2016, she was elevated to lieutenant and became an evening watch commander where her duties included developing new methods to improve unit operation and ensuring that officers under command were well versed in community and problem-oriented policing.

In 2016, Fraser was appointed as the Assistant Training Academy Director. She oversaw all recruits, firearms, intermediate, advanced, and specialized training for officers in DeKalb County. In 2021, Anita Fraser retired from the agency and became a major at Fulton County Sheriff's Office, overseeing training for officers in Fulton County.
